ORDER GRANTING PETITION

On May 25, 2004, the Board of Continuing Legal Education (the Board) filed a petition with this court regarding the status of certain members of the State Bar of Nevada (respondent attorneys) who failed to comply fully with the Supreme Court Rules governing continuing legal education. See SCR 205 – 215. Specifically, the Board petitions this court to order those respondent attorneys who are presently active to show cause why their membership status should not be changed to inactive and, from the date of such change of status, be barred from practicing law in the State of Nevada until reinstated under SCR 213. Further, as to those respondent attorneys who are already inactive, disabled or suspended, to show cause why their rights of reinstatement to active status should not

be conditioned upon full compliance with SCR 213, in addition to any conditions of reinstatement already imposed upon them.

On November 16, 2004, this court entered an order directing the respondent attorneys, including Randall R. Leonard, Sondra D. McCurry, Doris E. Nehme, Leonard J. Root and Ulrich W. Smith to show cause why this court should not grant the Board's petition to change their status from active to inactive and to condition their rights to be reinstated upon full compliance with SCR 213. The Board has since filed documents entitled "Consent to Dismissal," informing this court that Randall R. Leonard, Sondra D. McCurry, Doris E. Nehme, Leonard J. Root and Ulrich W. Smith have satisfied the requirements set forth in SCR 205 through 215. Accordingly, we conclude that Randall R. Leonard, Sondra D. McCurry, Doris E. Nehme, Leonard J. Root and Ulrich W. Smith have completed the requirements for reinstatement under SCR 213, and we dismiss the Board's petition with prejudice as to each of them.

The remaining respondent attorneys have failed to respond to our November 16, 2004, order. Accordingly, we grant the Board's petition as to these attorneys. The status of the following respondent attorneys shall be changed from active to inactive. The following respondent attorneys are prohibited from practicing law in the State of Nevada until reinstated as allowed under SCR 213:
