ORDER DENYING PETITIONS FOR  
WRIT OF PROHIBITION

These identical proper person original petitions for writs of prohibition ask this court to direct the district court to hold an evidentiary hearing to determine if the real parties in interest's attorneys have committed "continuous fraud" over the course of the underlying litigation. Petitioner Jo Ann Jackson also accuses Senior Judge Noel Manoukian of misconduct and asks this court to disqualify Judge Manoukian from presiding over Jackson's district court cases.

Jackson has the burden of providing this court with a statement of facts necessary for this court's understanding of all issues raised, and must attach to her petition all documents needed for this court to render its decision.<sup>1</sup>


We have considered these petitions, and we are not satisfied that this court's intervention by way of extraordinary relief is warranted



at this time. In particular, other than Jackson's conclusory statements and accusations, she has provided nothing to support our issuance of writs of prohibition. Accordingly, we deny these petitions.<sup>2</sup>
