


ORDER DENYING PETITION FOR WRIT OF MANDAMUS

This original petition for a writ of mandamus challenges the district court's order denying petitioners' motion to disqualify the real party in interest's counsel. We have considered this petition, and we are not satisfied that this court's intervention by way of extraordinary relief is warranted. Petitioners have not demonstrated that the district court manifestly abused its discretion,¹ particularly when there is no indication in the documentation before this court that Dennett & Winspear, LLP, ever represented Robert Jankovics or any other party in the underlying action.² Accordingly, we deny the petition.³

It is so ORDERED.
