## ORDER DENYING PETITION FOR WRIT OF CERTIORARI


This original petition for a writ of certiorari challenges a district court's affirmance of a justice's court decision. We have considered this petition, and we are not satisfied that this court's intervention by way of extraordinary relief is warranted. Specifically, we note that petitioner has failed to include any supporting documentation with its petition and

thus has failed to meet its NRAP 21(a) burden.<sup>1</sup> Accordingly, we deny the petition.<sup>2</sup>
