ORDER DENYING PETITION FOR WRIT OF MANDAMUS OR PROHIBITION

This original petition for a writ of mandamus or prohibition challenges a district court order denying petitioners' motion for rehearing regarding the district court's refusal to lift a stay for the purpose of allowing discovery to proceed in the underlying case.

A petition for a writ of mandamus is an extraordinary remedy, and whether a petition will be entertained is entirely within the discretion of this court.¹ Likewise, a petition for a writ of prohibition is an extraordinary remedy, and whether such a petition will be entertained is purely discretionary with this court.² We have considered this petition and we are not satisfied that this court's intervention by way of extraordinary relief is warranted.³ Accordingly, we deny the petition.⁴

It is so ORDERED.
