ORDER DISMISSING APPEAL



This is an appeal from a judgment of conviction, pursuant to a guilty plea, of one count of battery causing substantial bodily harm, four counts of being an ex-felon in possession of a firearm, and one count of possession of a controlled substance. Sixth Judicial District Court, Humboldt County; Richard Wagner, Judge.

This court's preliminary review of this appeal revealed a jurisdictional defect. Specifically, the judgment of conviction was entered by the district court on August 25, 2005, but the notice of appeal was not filed until November 15, 2005, after the thirty-day appeal period prescribed by NRAP 4(b).

Accordingly, on December 7, 2005, this court ordered counsel for appellant to show cause why this appeal should not be dismissed. On December 23, 2005, counsel filed a response, in which he informs this court that the "parties agreed that for appellate purposes the service date of the Judgment of Conviction would be November 8, 2005."

NRAP 4(b)(1) requires that the notice of appeal in a criminal matter be filed in the district court within 30 days after the entry of the judgment being appealed from. NRAP 4(b)(1) specifically provides that the time for filing the notice of appeal runs from the entry of the

judgment, not from service of the judgment.¹ Moreover, this court has held that jurisdiction cannot be conferred upon this court "by the consent or stipulation of the parties or their counsel."²An untimely notice of appeal fails to vest jurisdiction in this court.³ We conclude that the notice of appeal was untimely, and that we lack jurisdiction to entertain this appeal. Accordingly, we

ORDER this appeal DISMISSED.
