ORDER DENYING PETITION FOR WRIT OF MANDAMUS OR PROHIBITION


This is an original petition for writ of mandamus, or in the alternative, prohibition, from district court orders appointing a special master to oversee repair efforts during the pre-litigation phase in a

constructional defect case. Petitioners have also filed a motion to stay enforcement of the orders.
