


ORDER DISMISSING APPEAL AND CROSS-APPEAL


Pursuant to the stipulation of the parties, and cause appearing, the appeal of Reno Iron Works, Andrea G. Pelter, Ralph M. Shindler and A. Barry Cox is dismissed. The parties shall bear their own costs and attorney fees. NRAP 42(b).

On June 6, 2008, this court entered an order directing cross-appellant John F. Sieben to file his Civil Proper Person Appeal Statement on cross-appeal by September 4, 2008. That order cautioned cross-appellant that failure to comply may result in the dismissal of his cross-appeal.<sup>1</sup> To date, cross-appellant has failed to file his Civil Proper Person Appeal Statement. Accordingly, the cross-appeal is dismissed as abandoned.
