
ORDER DISMISSING APPEAL IN DOCKET NO. 51013

These are appeals from district court summary judgments in a personal injury action. Eighth Judicial District Court, Clark County; Michelle Leavitt, Judge.


Docket No. 51013 is an appeal from a January 14, 2008, interlocutory order granting summary judgment to respondent Regional

Transportation Commission of Southern Nevada, while Docket No. 53730 is an appeal from the final judgment in the consolidated cases below. As interlocutory orders generally are not appealable, but instead may be considered in the context of an appeal from the final judgment, Consolidated Generator v. Cummins Engine, 114 Nev. 1304, 971 P.2d 1251 (1998), we hereby dismiss the appeal in Docket No. 51013. The clerk of this court shall add the Regional Transportation Commission of Southern Nevada as a respondent to the appeal in Docket No. 53730. The court reporter's certificate should be filed in Docket No. 53730, and the opening brief remains due on or before December 9, 2009. Briefing shall thereafter proceed in accordance with NRAP 31(a)(1).

It is so ORDERED.
