ORDER DISMISSING APPEAL IN DOCKET NO. 54590


Docket No. 54590 is an appeal from a district court order denying a motion for a change of venue.¹


On May 13, 2010, this court issued an order that, among other things, directed appellants to show cause why the appeal pending in Docket No. 54590 should not be dismissed as moot. Appellants have filed a response, as directed. Having considered appellants' arguments regarding why they believe this appeal should not be dismissed as moot, we conclude that appellants' arguments lack merit. Accordingly, as we conclude that the appeal pending in Docket No. 54590 is moot, we order it

dismissed. University of Nevada v. Tarkanian, 95 Nev. 389, 394, 594 P.2d 1159, 1162 (1979) (stating that the duty of this court is to resolve actual controversies and not to opine on moot questions or abstract propositions).
