## ORDER OF AFFIRMANCE

These are proper person appeals from orders of the district court denying a motion to correct an illegal sentence filed in district court cases C215290 and C215291. Eighth Judicial District Court, Clark County; Michael Villani, Judge. We elect to consolidate these appeals for disposition.<sup>1</sup> NRAP 3(b).

In his motions filed on August 20, 2009, appellant claimed that his guilty plea was invalid, and thus his conviction illegal, because the district attorney had a conflict of interest, his plea was coerced, the

SUPREME COURT OF NEVADA district court participated in the plea negotiations, and the charges did not fit the conduct. These claims fell outside the very narrow scope of claims permissible in a motion to correct an illegal sentence, and therefore, we conclude that the district court did not err in denying the motions. <u>Edwards v. State</u>, 112 Nev. 704, 708, 918 P.2d 321, 324 (1996). Accordingly, we

ORDER the judgments of the district court AFFIRMED.
