ORDER DISMISSING APPEAL AND ORDER

Docket No. 34857 is an appeal from an order of the district court denying appellant's post-conviction petition for a writ of habeas corpus. Docket No. 35368 is an appeal from the district court's denial of appellant's motion for reconsideration of the district court's order denying his habeas corpus petition.

On January 7, 2000, counsel filed a "motion to consolidate appeals and to extend court appointed representation to consolidated appeal." On February 4, 2000, this court extended the district court's order appointing counsel to apply to the appeal in Docket No. 34857, but declined to consolidate these matters at that time. For the reasons discussed below, we deny appellant's motion to consolidate.

In the February 4, 2000 order, this court also ordered appellant to show cause why the appeal in Docket No. 35368 should not be dismissed for lack of jurisdiction. In response to this court's order, appellant concedes the appeal in Docket No. 35368 should be dismissed for lack of jurisdiction. Accordingly, we dismiss the appeal in Docket No. 35368.

On February 23, 2000, appellant filed a stipulation for an extension to file an opening brief in Docket No. 34857. Cause appearing, appellant shall have to and including March 24,

2000, within which to file and serve the opening brief and appendix required by NRAP 30 and 31. Thereafter, briefing shall proceed in accordance with the schedule set forth in NRAP 31.

On February 23, 2000, appellant also filed a motion to have the record in Docket No. 35368 transferred to Docket No. 34857. We note that this court has not received any records in Docket No. 35368. Accordingly, we deny appellant's motion.

We further note that no transcript request form or certificate of no transcript request has been filed in this court. NRAP 9(a). A certified copy of the transcript for the August 20, 1999 district court proceedings was filed in this court in Docket No. 34857 on February 7, 2000; however, it is unclear if additional transcripts will be necessary to prosecute this appeal. Accordingly, counsel's prompt compliance with NRAP 9 is required, and appellant shall file a transcript request form or a certificate of no transcript request in this court within 10 days from the date of this order.

It is so ORDERED.
