## ORDER DENYING PETITION FOR WRIT OF MANDAMUS OR PROHIBITION

This original petition for a writ of mandamus, or alternatively, prohibition, challenges a district court order denying a motion for summary judgment.

On February 2, 2012, petitioners Bashir Chowdhry, M.D. and Nauman Jahangrir, M.D. filed a response in support of their writ petition indicating that on January 19, 2012, the district court granted petitioners' "Re-Noticed Motion for Summary Judgment Based on Newly Discovered Evidence." On February 8, 2012, petitioner Tali Arik, M.D. filed a joinder in Chowdhry and Jahangrir's response, indicating that the district court dismissed the complaint in this action "against all remaining parties via a

Motion to Reconsider Motion for Summary Judgment and Joinder thereto." The district court docket entries show that the order granting summary judgment was filed on February 7, 2012, that the trial date in this action has been vacated, and that the Med-Mal Status Check panel has referred the case to the department for closure.

Since the district court has granted the re-noticed motion for summary judgment, this petition is now moot. Personhood Nevada v. Bristol, 126 Nev. \_\_\_, \_\_\_, 245 P.3d 572, 574 (2010). Accordingly, we ORDER the petition DENIED.
