appeal, we hereby dismiss this appeal as abandoned. See NRAP 3(a) (while failure to take any steps other than the filing of a notice of appeal does not affect the appeal's validity, it may be grounds for dismissal of the appeal).²

It is so ORDERED.

Code 39

Code 39, also referred to as 3 of 9 Code, is an alphanumeric, self-checking, variable length code that uses five black bars and four spaces to define a character. Three of the elements are wide and six are narrow. Note that the extended version of Code 39 (full 128 character set) is not supported.


Code 39 supports the following characters:

A Code 39 bar code symbol consists of the following elements:

- 26 uppercase letters.
- Ten digits.
- Seven special characters (-.\$/+% and a space).
- Start/stop character, which is depicted as an asterisk (*).


- Leading quiet zone.
- Start character.
- Data characters, with characters separated by an inter-character gap.
- Optional check character.
- Stop character.
- Trailing quiet zone.
