



ORDER DENYING PETITIONS FOR WRIT OF  
MANDAMUS OR PROHIBITION

These original petitions for a writ of mandamus or prohibition challenge an order of the district court denying petitioners' motions for summary judgment and dismissal of the complaint of the real parties in interest based on the statute of limitations. We have considered the petitions, the joint answer, and the joint reply, and we are not satisfied that this court's intervention by way of extraordinary relief is warranted at this time. See NRAP 21(b); Smith v. District Court, 107 Nev. 674, 818 P.2d 849 (1991); State ex rel. Dep't Transp. v. Thompson, 99 Nev. 358, 662 P.2d 1338 (1983). Accordingly, we deny the petitions.
