ORDER DISMISSING APPEAL

This is a proper person appeal from an order appointing a receiver and awarding attorney fees. Following the withdrawal of appellant's counsel, appellant submitted a motion to dismiss her appeal without prejudice. We denied the motion because an appeal may be dismissed only with prejudice. Appellant then submitted an unsigned motion to dismiss with prejudice, which was denied because it was unsigned.

Appellant then submitted a "Motion to Have Appeal Withdrawn with Prejudice," which was signed, but the text of which indicated that appellant might still wish to have the appeal heard on its merits. Accordingly, on November 12, 2002, we entered an order denying appellant's motion, and directing appellant to submit a response stating whether she wished to voluntarily dismiss her appeal or to have the appeal reviewed as a proper person appeal. The November 12 order granted appellant thirty days within which to submit her response, and

cautioned her that failure to submit a timely response could result in the dismissal of this appeal as abandoned.

Appellant has not responded to the November 12 order in any way. Accordingly, we conclude that appellant has abandoned her appeal, and we
