ORDER DISMISSING APPEAL

On July 20, 2000, a stipulation to dismiss this appeal and a settlement agreement were filed in this court. From a review of the documents, we could not determine whether respondent Nevada Power Company was included in the settlement agreement or whether the stipulation to dismiss this appeal was conditioned upon future events. Additionally, it appeared that Nevada Power Company might not be a proper party to this appeal. Accordingly, we directed appellants to file a report clarifying these matters.

On October 4, 2000, respondents City of Las Vegas, Jerry Keller and Edward V. Jones filed a motion for a remand. We deferred ruling on the motion, noting that if Nevada Power Company is not a party to this appeal and if the stipulation to dismiss this appeal is not conditioned upon future events, this appeal may be dismissed in its entirety. In such case, an order of remand appeared unnecessary.

On December 29, 2000, appellants filed a report indicating that Nevada Power Company is not a party to this appeal and that the stipulation to dismiss is not conditioned upon future events. Accordingly, the clerk of this court shall remove respondent Nevada Power Company from the caption on this court's docket. Pursuant to the settlement conference held in this matter, the stipulation of the parties and good cause appearing, we dismiss this appeal. We deny as moot respondents' October 4, 2000 motion for a remand.

It is so ORDERED.
