ORDER OF AFFIRMANCE

This is a proper person appeal from an order of the district court denying a motion to vacate, set aside, or correct an illegal sentence.¹ Fifth Judicial District Court, Nye County; Robert W. Lane, Judge.

In his motion filed on April 24, 2013, appellant claimed that his sentence was illegal because the State filed, on the same day as sentencing, a third amended information that did not include a count of habitual criminal. Appellant's claim fell outside the narrow scope of claims permissible in a motion to correct an illegal sentence as his sentence was facially legal and his claim did not implicate the jurisdiction of the district court. See Edwards v. State, 112 Nev. 704, 708, 918 P.2d

321, 324 (1996); Nev. Const. art. 6, § 6. Therefore, we conclude that the district court did not err in denying appellant's motion, and we

ORDER the judgment of the district court AFFIRMED.²
