



ORDER DENYING PETITION

This original petition for a writ of mandamus challenges a district court order denying a motion to apply Arizona law, or alternatively French and Texas punitive damages law, in a tort action. Having reviewed the petition, we decline to exercise our discretion to entertain the petition. *D.R. Horton, Inc. v. Eighth Judicial Dist. Court*, 123 Nev. 468, 475, 168 P.3d 731, 737 (2007) (recognizing this court's broad discretion in determining whether to consider a writ petition). Mandamus is an extraordinary remedy


and will not issue when petitioners have a plain, speedy, and adequate remedy at law. *Pan, v. Eighth Judicial Dist. Court*, 120 Nev. 222, 224, 88 P.3d 840, 841 (2004). Because petitioners have an adequate remedy at law by way of an appeal, we deny the petition.


It is so ORDERED.




