

*ORDER DISMISSING APPEAL*


This appeal was docketed in this court on May 25, 2023. Because the notice of appeal was not accompanied by the required proof of service, *see* NRAP 3(d)(1) (providing the notice of appeal must be served on all parties to the district court action and must “contain an acknowledgment of service or proof of service that conforms to the requirements of [NRAP]

25(d)”), on July 2, 2024, this court entered an order directing appellant to filed the required proof of service within 14 days. Appellant was cautioned that the failure to comply would result in the dismissal of this appeal.

On July 29, 2024, appellant filed a “Proof of Service of Notice of Appeal Opposition to the Perjury and Conspiracy of Rosemarie McMorris-Alexander Et Al. As a Response to Attached Exhibit 1, Supplement (sic) to Appellants’ (sic) Opening Brief, Motion to Disqualify Justice Lee and Proof of Service of the Joinder of Appeal.” This document does not include a certificate of service for any document and does not demonstrate that the notice of appeal was served on respondents. Because appellant has failed to provide proof the notice of appeal was served on respondents, this appeal is dismissed.

It is so ORDERED.<sup>1</sup>
