




ORDER DISMISSING APPEAL


This is a pro se appeal from a district court form order to statistically close case. Eighth Judicial District Court, Clark County; Anna C. Albertson, Judge.

Review of the notice of appeal and documents before this court reveals a jurisdictional defect. This court "may only consider appeals authorized by statute or court rule." *Brown v. MHC Stagecoach, LLC*, 129 Nev. 343, 345, 301 P.3d 850, 851 (2013). No statute or court rule authorizes an appeal from a form order statistically closing a case. *Id.* at 345-47, 301 P.3d at 851-52. Accordingly, this court lacks jurisdiction and

ORDERS this appeal DISMISSED.
