## ORDER DISMISSING APPEALS


These are proper person appeals from an order of the district court dismissing appeals from the municipal court.<sup>1</sup> We elect to consolidate these appeals for disposition.<sup>2</sup> Our review of these appeals reveals jurisdictional defects. Specifically, appellant's cases arose in the municipal court. The district court has final appellate jurisdiction over a case arising in the municipal court.<sup>3</sup> Accordingly, we conclude that we
