
ORDER DENYING PETITION FOR
WRIT OF MANDAMUS OR PROHIBITION


This is an original petition for a writ of mandamus or prohibition challenging the district court's pronouncement that it intends


to apply Nevada law to all of the plaintiffs' causes of action. We have considered the petition, and we are not satisfied that this court's intervention by way of extraordinary relief is warranted at this time.¹ In particular, it appears that petitioner has a plain, speedy, and adequate remedy in the form of an appeal from any adverse judgment.² Accordingly, we deny the petition.³ The motion for a stay is denied as moot.

It is so ORDERED.
