ORDER DENYING PETITION FOR WRIT OF CERTIORARI


This petition for a writ of certiorari challenges Sparks Justice of the Peace Susan Deriso's refusal to exonerate a \$53,500 bail bond, and Washoe County District Judge Steven R. Kosach's refusal to reverse the justice's court judgment.<sup>1</sup> A writ of certiorari may issue to arrest proceedings that exceed an inferior tribunal's jurisdiction, when there is

no appeal, or any plain, speedy and adequate remedy.<sup>2</sup> We have considered the writ petition and supporting documents, and we conclude that our intervention is not warranted. Petitioners cannot produce the defendant, but they also have no evidence that she was deported or returned voluntarily to Mexico. Thus, their arguments are speculative and they have not provided adequate grounds for extraordinary relief. We

ORDER the petition DENIED.<sup>3</sup>
