ORDER LIFTING BANKRUPTCY STAY AND DISMISSING APPEAL

On March 17, 2004, this court ordered this appeal stayed pursuant to the mandatory provisions of federal bankruptcy law. See 11 U.S.C. § 362(a). Thereafter, the parties filed a status report on April 7, 2004, informing this court that the automatic stay has been lifted by the United States Bankruptcy Court for the District of Nevada. Attached to the status report is a copy of the bankruptcy court's order that lifts the automatic bankruptcy stay. Accordingly, we conclude that this appeal is no longer subject to the automatic bankruptcy stay and we lift the stay imposed on March 17, 2004.


Also attached to the status report is a copy of the bankruptcy court's order approving the settlement between the parties. See Fed. R.

Bankr. P. 9019(a). Pursuant to the settlement conference; the motion for voluntary dismissal filed by appellant American Insurance Company; the stipulation for dismissal of appeal filed by appellant Flippin's Trenching, LLP, and respondents; and cause appearing, we dismiss this appeal. NRAP 42(b).
