
ORDER DISMISSING APPEAL


This is a proper person appeal from a district court order dismissing the underlying case. First Judicial District Court, Carson City; William A. Maddox, Judge.


On September 9, 2005, this court entered an order directing appellant to file the civil proper person appeal statement attached to that order on or before October 19, 2005. Appellant did not file the civil proper person appeal statement or a motion for an extension of time in which to file that statement. Accordingly, on January 24, 2006, this court entered an order directing appellant to show cause why his appeal should not be

dismissed as abandoned based on his failure to file the civil proper person appeal statement within thirty days from the date of that order. Appellant's response to this court's show cause order was due on February 23, 2006. To date, appellant has not responded to this court's January 24 order. Moreover, we note that the copies of our September 9 and January 24 orders mailed to appellant were returned and no forwarding address has been provided. It thus appears that appellant has moved and left this court unable to communicate with him by failing to notify this court of any address change. We therefore conclude that appellant has abandoned this appeal, and we

ORDER this appeal DISMISSED.<sup>1</sup>
