**ORDER VACATING HEARING**

On November 4, 2021, proposed Plaintiff in Intervention, Alexander Falconi d/b/a Our Nevada Judges, by and through counsel Luke A. Busby, filed a *Motion for Limited Intervention to Provide Electronic Coverage Under SCR 230*. On November 10, 2021, proposed Plaintiff in Intervention filed a *Supplement to Motion for Limited Intervention to Provide Electronic Coverage Under SCR 230*. The State of Nevada filed a *Response to Motion to Intervene* on November 12, 2021. On November 19, 2021, proposed Plaintiff in Intervention filed a *Request for Submission*<sup>1</sup>. On November 23, 2021, the Court issued a *Corrected Order Setting Virtual Hearing* and scheduled this matter for a hearing to be conducted on January 26, 2022.

Although this *Motion* was not filed or briefed in *State of Nevada v. Stewart Evans Handte*, CR19-1535B, the outcome of this *Motion* will have an impact on the *Handte*

2 participate in this *Motion* hearing.


3 Although Handte is currently represented by counsel, Handte has made an oral  
4 motion to relieve counsel and a hearing pursuant to *Faretta* was scheduled to occur on  
5 January 19, 2022. As a result of circumstances outlined in the record, a warrant has  
6 been issued for Handte and until such time as he is in custody and able to appear for  
7 the *Faretta* hearing to determine status of representation, the instant *Motion* is

8 ORDERED HELD IN ABEYANCE.

9 The hearing scheduled for January 26, 2022, is VACATED.
