You will be responsible for all costs associated with preparing transcripts – a \$100 deposit is required to start the process. Upon completion, a balance may be due, or you may receive a partial refund of your deposit.

For transcription services, in addition to the \$40 fee, for the original draft and any copy to be delivered:

- Within 24 hours after it is requested, \$8.03 per page for the original draft and one copy, and \$3.62 per page for each additional copy;
- Within 48 hours after it is requested, \$6.01 per page for the original draft and one copy, and \$2.72 per page for each additional copy;
- Within 4 days after it is requested, \$5.01 per page for the original draft and one copy, and \$2.26 per page for each additional copy; or
- More than 4 days after it is requested, \$3.80 per page for the original draft and one copy, and \$1.00 per page for each additional copy.
