RENEWED ORDER GRANTING MEDIA ACCESS TO OUR NEVADA JUDGES, INC.

This Court is in receipt of Our Nevada Judges, Inc.'s ("ONJ") December 5, 2023 Request for Order re Electronic Coverage at Court Proceedings, requesting permission to record the proceedings scheduled to take place January 22, 2023 (sic) at 9:00 a.m. in the above-referenced matters. A two-week trial for these matters is currently scheduled to begin January 22, 2024.

This Court entered its Order Granting Media Access to Our Nevada Judges, *Inc.* on August 21, 2023 granting media access to record throughout the duration of trial, previously scheduled to take place August 28, 2023.

The Court finds no reason to vary from its prior *Order* and RENEWS its *Order* as follows:

Before the Court is the matter of media access to the trial in this case, which is set to commence on January 22, 2024. On December 5, 2023, Our Nevada Judges, Inc., (hereinafter "ONJ") representative Alexander Falconi formally requested permission under Nevada Supreme Court Rule 230(1) to record trial proceedings.

The Court hereby **GRANTS** ONJ media access to cover the upcoming Court proceedings. ONJ may post video recordings and related news stories to its site daily. Further, ONJ is reminded to respectfully adhere to all Court rules and procedures for the duration of its media coverage.

Being fully informed, the Court finds no reason to vary from Nevada Supreme Court Rule 230(1) presumption that these open proceedings are subject to electronic coverage. Specifically, the Court notes that Mr. Falconi testified that he intends to be present during the majority of the proceedings and ONJ will not film the *voir dire* process or the seated jury members at any point during the trial. Mr. Falconi testified that the recordings will not be livestreamed and can be posted at the conclusion of the trial in order to ensure the rule of exclusion is not violated inadvertently.

The Court **ORDERS** ONJ to adhere to the following conditions:

- 1) ONJ shall not record any part of the jury selection process nor record any of the potential or seated jurors;
- 2) ONJ shall not record any computer screen in the line of sight of the cameras; and
- 3) ONJ shall edit out any obvious playing to or interaction with the camera from any witness or participant in the Court.

¹ The Court acknowledges that there is no indication ONJ were seeking to record either the jury selection process or the seated jurors.

1	Accordingly, daily media access under Nevada Supreme Court Rule 230(1) for
2	ONJ is GRANTED subject to the aforementioned conditions.
