

2024 Candidate's Guide

March 2, 2024

The 2024 judicial election consists of a non-partisan primary to be held on June 11 and general election to be held on November 5. This guide is meant to assist judicial candidates by explaining the policy¹ and purpose of candidate profiles as well as the election page.

Candidate Profile

All judicial candidates have a profile, accessible through the [elections](#) page and candidate [index](#). Recent mentions on the [home](#) page will also provide for linking to a candidate's profile. A candidate² may request changes and provide information to research@ournvadajudges.com.

A candidate may provide their website, which is posted on their profile accordingly. The research team will scan the internet once for candidate websites. This scan has already occurred.

Photo

A candidate may provide a preferred photo. If a photo is not provided, it will be gleaned from the internet. A submitted photo ideally would be formatted as 200x267 pixels, otherwise the photo will be resized and cropped at administration's discretion. The research team has already scanned for photos and will not do so again for the remainder of the election.

Statement

A candidate may provide an 80 character statement, which is posted to their profile and appears on their Election Card. If a statement is not submitted, it will be gleaned from the candidate's website by the research team. If a statement is submitted in excess of 80 characters, administration will truncate the statement at their discretion.

Description

A candidate may provide a description, which is posted to their profile. If a description is not provided, it will be gleaned from the candidate's website. The description is an objective biography of the candidate. Subjective³ information will be omitted. Superfluous⁴ information that is already available in other areas of the candidate's profile will be omitted. Administration may request verification of certain information.

Social Media

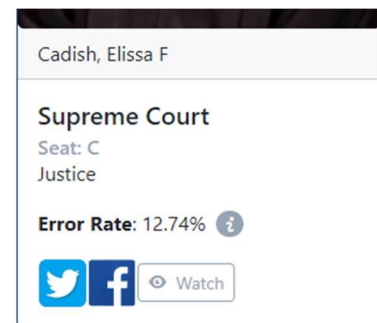
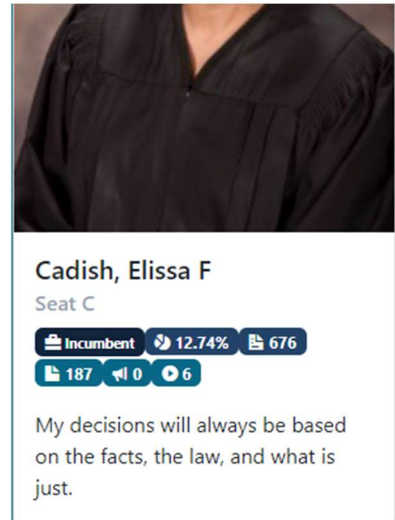
A candidate may provide a Facebook, Twitter/X, or YouTube link, which will appear on the candidate's profile. The research team has already scanned for social media links and will not do so again for the remainder of the election.

Opponents

A candidate's opponents will appear on their candidate profile.

Judges

A candidate that is or has served as a judge will have their candidate profile embedded in their judicial profile. Accordingly, voters will have access to the judge's appellate dispositions and statistical data.

Articles

All articles posted by approved publishers will appear in the articles tab. Any person may submit an article, request removal of an article, or challenge the contextual headline of an article. Such requests are reviewed by administration and a decision is made consistent with existing policy as to what action to take. It is the policy of Our Nevada Judges to post all articles, so if an article is missing it is not intentional and should be brought to the attention of research@ournevadajudges.com.

Videos

All videos posted by approved publishers will appear in the videos tab.

Endorsements

All endorsements posted by approved organizations will appear in the endorsements tab. It is the policy of Our Nevada Judges to post all endorsements, so if an endorsement is missing it is not intentional and should be brought to the attention of research@ournevadajudges.com. The research team will scan for endorsements in waves prior to and after the primary election.

Election Page

The election page contains all judicial jurisdictions and corresponding departments up for election. It is the policy of Our Nevada Judges to post all judicial candidates and all races, so if a candidate is missing it is not intentional and should be brought to the attention of admin@ournevadajudges.com.

The election page also contains Election Cards with tidbits of information relevant to candidates running in the election. A report articulating the algorithm controlling how these cards are rendered and updated will be published shortly.

Interview

It is the policy of Our Nevada Judges to invite all candidates for a recorded interview which will publish to their candidate profile. If you have not received an invite, it is not intentional and likely due to contact information not having been provided to the election registrar.

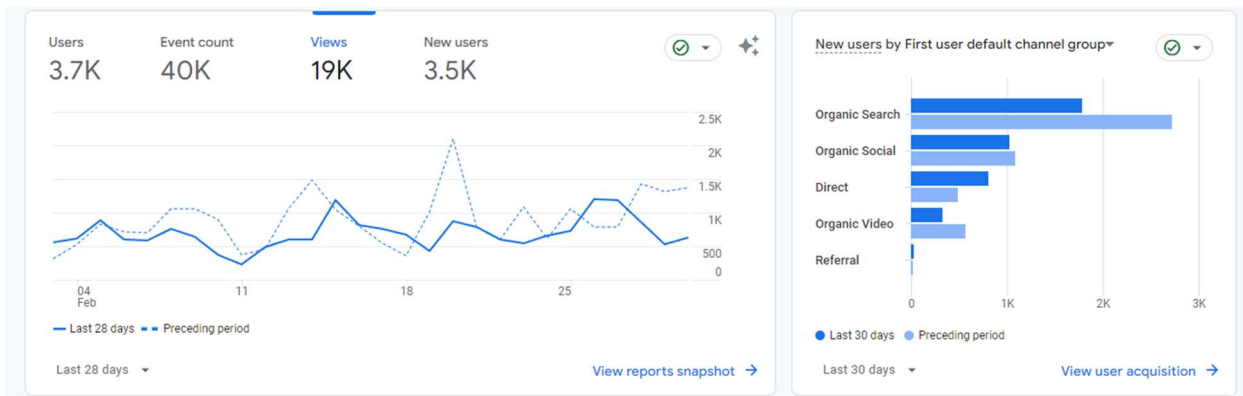
