2	Our Nevada Judges, Inc. ("ONJ"), has asked for more than SRCR 3(5)(c)
4	requires. ONJ has asked for: 1) access to the docket index; 2) any sealing order <sup>1</sup> .
5 6	SRCR 3(5)(c) does not provide for the relief being requested by ONJ. SRCR
7	3(5)(c) provides:

An order entered under these rules must, at a minimum, require that the following information is available for public viewing on court indices: (i) the case number(s) or docket code(s) or number(s); (ii) the date that the action was commenced; (iii) the names of the parties, counsel of record, and the assigned judge; (iv) the notation "case sealed"; (v) the case type and cause(s) of action, which may be obtained from the Civil Cover Sheet; (vi) the order to seal and written findings supporting the order; and (vii) the identity of the party or other person who filed the motion to seal. Nowhere in SRCR 3(5)(c) does it provide for the unsealing of the docket index and for notice of hearings to be publicly available.
