11 **ORDER FOR CAMERA ACCESS TO COURT PROCEEDINGS**

12 WHEREAS this matter is not a sealed case, there is a presumption that the  
13 case is subject to electronic coverage pursuant to SCR 230(2); and,

14  
15 WHEREAS, because this matter is a guardianship case, the Court is  
16 and the confidentiality of the addresses of the participants  
concerned with the right of privacy for the minor child; and,

17 THE COURT HAVING CONSIDERED all of the factors set forth in SCR 230(2),  
18 the Court finds and orders as follows regarding the SCR 230(1) media request  
19 submitted by Our Nevada Judges, Inc. in this matter:

21 1. The Court determines camera access to proceedings, in compliance with the  
22 Court's policy and the specific orders set forth herein, WOULD NOT distract  
23 participants, impair the dignity of the Court or otherwise materially interfere with the  
24 achievement of a fair trial or hearing herein.

26 2. Therefore, the Court hereby GRANTS permission for camera access to Our  
27 Nevada Judges, Inc., as requested for each and every hearing on the above-entitled

1 case, at the discretion of the Judge, and unless otherwise notified. This Order is in  
2 accordance with Nevada Supreme Court Rules 229-249, inclusive, and is subject to  
3 reconsideration upon Motion of any party to the action.

5 3. However, in order to protect the privacy of the the minor child and witnesses  
6 involved in this matter, there shall be no live streaming of the electronic coverage  
7 and when the electronic coverage is published, the faces of the minor child and  
8 witnesses shall be visually blurred so as to be unrecognizable; and, residential  
9 addresses shall be rendered inaudible.
