12 **ORDER ON MOTION TO SHORTEN TIME**

13 On September 5, 2024, an ex parte motion for order shortening time was filed by  
14 proposed intervenors The New York Times Company, CNN, The Associated Press, National  
15 Public Radio, Inc., The Washington Post, and Reuters in connection with their *Motion to*  
16 *Intervene, Motion for Access, and Motion to Unseal on Order Shortening Time*. The  
17 proposed intervenors have shown good cause to shorten time to respond to the motion,  
18 pointing to their First Amendment rights of access to Courts, and the need to be heard prior  
19 to hearings in this case scheduled during the month of September 2024, which are presently  
20 closed to the public by court order. Under WDCR 11(3), “[f]or good cause shown, the judge  
21 who is to try the case, or if the judge is not in the courthouse during regular judicial hours, the  
22 chief judge . . . may make an ex parte order shortening time upon a satisfactory showing to  
23 the judge that a good faith effort has been made to notify the opposing counsel of the

1 motion.” All parties in this case have received notice of the motion through the Court’s  
2 electronic filing system.

3 **IT IS HEREBY ORDERED** any opposition to the *Motion to Intervene, Motion for*  
4 *Access, and Motion to Unseal on Order Shortening Time* shall be filed on or before  
5 September 8, 2024. Any reply in support of the motion shall be filed on or before September  
6 9, 2024, and any party may file a request for submission of the motion on or after that date.
