5 electronic coverage.” *Id.* “A judge shall make particularized findings on
6 the record when determining whether electronic coverage will be allowed
7 at a proceeding, in whole or in part.” *Id.* SCR 230(2) lists six (6) factors
8 which the Court should consider when resolving any dispute over a Media
9 Request. *Id.*; see also *Our Nevada Judges, Inc. v. Second Judicial Dist.*
10 *Court in & for Cnty. of Washoe*, 88483, 2024 WL 3841691, at *1 (Nev. Aug.
11 14, 2024).
