Our Nevada Judges (hereafter 'ONvJ') was established in 2014 and provides statistical analysis on each judicial district and corresponding judicial department of the State, as well as electronic coverage of judicial proceedings.

This is the first complaint ever made by Our Nevada Judges against a judicial officer.

On June 30, 2020, ONvJ asked to record and broadcast Payne v. DETR. Exhibit 1. District Judge Barry Breslow (hereafter 'Breslow') granted permission. Exhibit 2. Within hours, ONvJ began to receive a massive influx messages from citizens concerned, who wanted to watch. Certain questions asked needed to be forwarded to a court official. ONvJ brought to the attention of the Court these questions. Exhibit 3. On July 1, 2020, the court took keen interest in the fact that ONvJ intended to broadcast live, and denied ONvJ's request to do so, directing viewers to instead use the government's live feed on Zoom posted to the court's website. Exhibit 4. Exhibit 5. Exhibit 6. On July 7, 2020, ONvJ immediately began to receive messages from angry viewers who could not connect to Zoom because it was at maximum capacity. Court staff struggled to start the hearing on time because too many participants were in Zoom. More upsetting, is the fact that several other media outlets went live, despite ONvJ having been forbidden the right to do so. Exhibit 7. Exhibit 8.

ONvJ has repeatedly stated, that unnecessary restrictions imposed on media coverage does little harm to the organization, but is a tremendous disservice to the citizenry of this State. Breslow's failure to make findings as required by SCR 230(1) is troubling as well. In this particular case, Breslow failed to provide any reasoning as to why live coverage from ONvJ was forbidden, despite the Court itself being providing live coverage through Zoom. This is the type of conduct that undermines the public's confidence in the judiciary, and fosters suspicion.

ONVJ has recorded and broadcast live from the Supreme Court of Nevada, Court of Appeals, Tenth Judicial District Court, Ninth Judicial District Court, Eighth Judicial District Court, Reno Justice Court,

and Las Vegas Justice Court, producing content that has accrued over 4 million watch time minutes in YouTube alone.

Ultimately, ONvJ was notified that no media were allowed to cover the proceedings live. Exhibit 8. Ironically, in violating the Breslow's directive, the major media outlets probably saved the Second Judicial District Court from a wave of outrage and embarrassment that would've followed when thousands of people found themselves unable to watch via Zoom.

It is inappropriate to restrict live coverage of judicial proceedings to a government medium; and, it is embarrassing and disgraceful that the same medium made available by the government isn't able to handle the influx of traffic.

Please work to implement a formal media policy that allows for appellate scrutiny of these decisions, consistent with SCR 243. The Second Judicial District Court is the only one that handles media requests through email back channels, and stands out in sharp contrast to the other judicial districts as the least transparent. The Second Judicial District Court is not a law unto itself, it answers to the Supreme Court of Nevada and must comply with the procedures set forth so as to allow for its decisions regarding media covered to be scrutinized by our appellate panels.

The citizens of this State deserve better.
