

*ORDER GRANTING MOTION  
AND VACATING ORDER DIRECTING ANSWERS*

Petitioner has filed a motion to amend petition and for leave to supplement the appendix, explaining that, after the petition was filed, the chief judge issued an order adopting the probate commissioner's recommendation in Case No. PR23-00813. Petitioner's motion is granted; however, the documents attached to the motion for filing appear to contain

an error, in that the district court docket numbers listed on the front page do not conform with the district court docket numbers listed in the errata filed on November 14, 2024. Accordingly, this court declines to file the submitted documents, and petitioner shall have 7 days from the date of this order to file and serve a corrected amended petition, appendix index, and supplemental appendix.
