The context of the post and share, as well as the editing in of Our Nevada Judges' ('ONvJ') name and logo, makes it appear as though ONvJ published support for Mr. Phillips' lawsuit, and that Mr. Phillips was sharing the counterfeit publication to exploit ONvJ's credibility with the public and legal community. The distinction between his attack organization and ONvJ is deliberately hidden, and instead of leading the public to believe it is another attack post against ONvJ, actually impersonates ONvJ and makes it appear to the public that his lawsuit has ONvJ support. | | | | | | | | | |
