*ORDER DIRECTING ANSWERS*

This is an original petition for a writ of mandamus seeking to compel three district courts to allow SRCR 3(5)(c) access and electronic coverage of civil proceedings.

Having reviewed the petition and supporting documents, this court concludes that answers may assist this court in resolving the petition. Therefore, real parties in interest, as well as respondents District Judge

Lynn K. Jones and District Judge Gregory G. Gordon, shall have 21 days from the date of this order to file and serve answers, including authorities, against issuance of the requested writ. NRAP 21(b)(1). In lieu of an answer, any real party in interest may file and serve a response within the same timeframe indicating that they do not oppose issuance of the requested writ. Petitioner shall have 7 days from the date of the last-filed answer to file and serve any reply.
